Surveillance: Ambiguities and Asymmetries

Contemporary surveillance is characterised by ambiguities and asymmetries. Surveillance results from different desires and rationales: control, governance, security, profit, efficiency but also care, empowerment, resistance, and play. Furthermore it can have both positive and negative outcomes for individuals and these may lead to intended or unintended consequences. Surveillance is never neutral. Surveillance is always about power and that power is increasingly asymmetric. Surveillance practices are also changing and as 'smart' surveillance systems proliferate utilising and generating 'Big Data' new forms of ambiguity and asymmetry arise. This event provides a rare opportunity to meet in the one place the foremost global academics, activists, journalists, policymakers, and think tanks in the surveillance studies field, which continues to shift its influence from the fringes of sociological studies to one that is increasingly informing policy, media and citizens.

The 6th bi-annual SSN conference will see Edward Snowden's legal attorney, Ben Wizner of the American Civil Liberties Union, speak on a dedicated "Surveillance after Snowden" panel, together with Caspar Bowden and Katarzyna Szymielewicz.



Unless you are staying nearby, the best way to get to the venues is by taking the underground. The nearest stops are Universitat (L1, red line; L2, purple line) and Catalunya (L1, red line; L3, green line).

From the airport

Barcelona has two terminals. T1 is only serviced by bus. T2 is serviced by bus and train.

Bus

You can take the “Aerobus”, a bus **service** that connects the **Airport** with the **centre of Barcelona** in less than 30 minutes, leaving every 5-10 minutes every day of the year. If you want to go to the venues, get off at the 4th stop, ‘Universitat’ (the last stop is ‘Catalunya’, still walking distance to the venues).

Tickets can be bought on the bus and cost 5,90/10,20€ (single/return valid for 15 days). For more information visit their site: <http://www.aerobusbcn.com/>

Train

A train leaves T2 towards Barcelona every 20-30 minutes and takes 30 minutes to reach the city centre (Plaça Catalunya), near the venues. You can get a single ticket or a T-10 valid for 10 trips in any public service which can be used by different people. At night

There is also a night bus, the N17, which goes to Plaça Catalunya and runs every 20 minutes between 10pm and 5am.

Taxi

Another option is to take one of the official city taxis. These are yellow and black and a green light on the roof indicates they are available. The ride should cost between 25 and 30€.

Practical information at the venues

Registration desk

The registration desk will open from 08:30 on Thursday April 24th until noon on Saturday April 26th.

On Thursday and Friday it will be located in front of UB Aula Magna, on the 4th floor. To get there you must go through the main entrance of the Faculty (c/ Montalegre, 6) and reach the forth flour (there are lifts and staircases). We aim to have someone there to help you at all times. But, if in the unlikely event you do not find anyone there, please refer to a member of our team (ORG in their badges).

On Saturday it will be located at the hall of CCCB Aula 1.

Registration fees for the whole conference include the conference pack, refreshment for the three days and lunch on Thursday and Friday.

On arrival at the reception desk you will be given your conference pack, including the badge. The badge will be needed to enter sessions, the plenaries, and to access the catering area (UB Aula Magna), so please wear it at all times.


Open plenary session


